Terms and Conditions of Ajinomoto Malaysia TUMIX® 2023 (the “Contest”)

Contest Period:

1. This contest is valid from **15 February 2023, 00:00:00** to **19 March 2023, 11:59:59** following (UTC+08:00) Kuala Lumpur, Malaysia time zone (“Contest Period”).

Contest Eligibility:

2. Entries must be submitted within the respective qualifying date with the right tag (@MyAjinomoto) and hashtag (#AjinomotoMY #TumixLah) completed with photo and/or video and recipe. Otherwise, the entry will be disqualified. Ajinomoto Malaysia Bhd (“the Organizer”) may at its sole discretion amend, change or extend the qualifying dates for any of the qualifying weeks.
